On the other hand, nine commenters suggested that HHS expand the scope of the regulations to cover more of the entities that use, disclose, generate, maintain, or receive protected health information, however defined. For example, the Workgroup on Electronic Data Interchange wrote that all entities involved in electronic exchange of individually identifiable health information should be included in the rule as health care clearinghouses. Some respondents specifically remarked that the definition of health plan needed to be broadened so that the same rules apply to other types of insurers, such as life, disability, workerscompensation, automobile, and property-casualty insures. According to the National Association of Insurance Commissioners, in creating their Health Information Privacy Model Act, they concluded it was illogical to apply one set of rules to health insurance carriers but different rules, or no rules, to other carriers that were using the same type of information. However, the Health Insurance Association of America commented that health plans should not include long-term care, disability, or dental insurance because applying the rule to these products may exceed the scope of the Secretarys authorization under HIPAA. Providers and patient rights advocates mentioned several other individuals and organizations they believe should be covered by the rule, including employers, public health officials, marketing firms, and researchers. The American Medical Association contended that such secondary users are the ones who are most likely to wron
