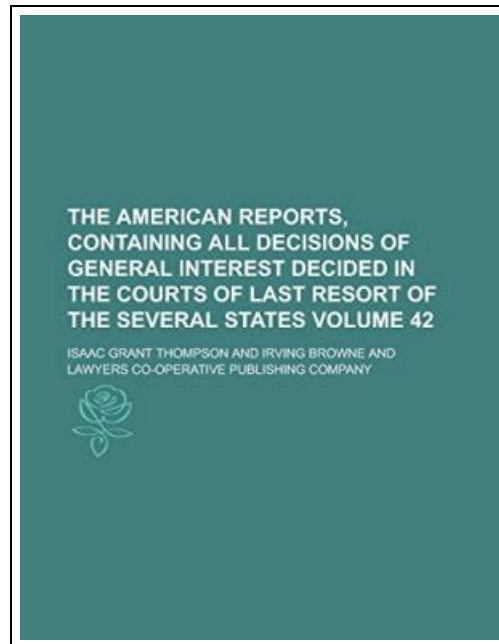

S. 702, it was observed that Corporations are liable for every wrong they commit, and in such cases the doctrine of ultra vires has no application. They are also liable for the acts of their servants while such servants are engaged in the business of their principal, in the same manner and to the same extent that individuals are liable under like circumstances. An action may be maintained against a corporation for its malicious or negligent torts, however foreign they may be to the object of its creation, or beyond its granted powers. It may be sued for assault and battery, for fraud and deceit, for false imprisonment, for malicious prosecution, for nuisance and for libel. It is also expressly held in the following cases that an action for malicious prosecution can be maintained against a corporation: Copely v. Machine Co., 2 Woods, 494; Ricard v. Central Pacific R.
