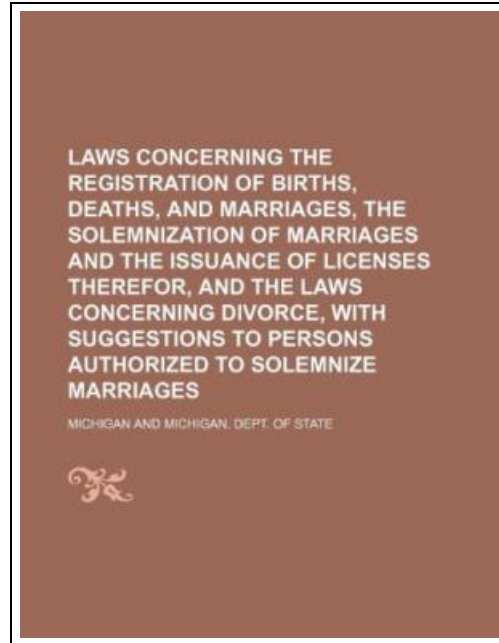

Not illustrated. 1900 Excerpt: :the trial, and filed the day after it was made, reciting that he was a necessary and material witness, that affiant was not till then advised of his name, or of the character of his testimony, and that he had communicated the name of the person to defendant s attorney. A marriage certificate, when accompanied by proof of the identity of the parties, is admissible to prove marriage in a prosecution for adultery. An extra judicial confession by defendant of his marriage is not alone, sufficient proof thereof to sustain a conviction of adultery. On a prosecution for adultery, the husband of the one with whom he is alleged to have committed the offense may testify to his marriage to her. A wife who has instituted prosecution of her husband for adultery cannot testify that she is his wife: 2 How. An. Stat., section 7546, providing that in a proceeding instituted by the husband or wife in consequence of adultery, they shall be competent to testify: People v. Isham, 109 Mich. 72. In a prosecution of a man for adultery, his wife cannot testify for the state as to her marriage to and cohabitation with defendant. The testimony of the clergyman and others participating in a marriage ceremony in a foreign country between defendant and a certain woman was admissible. Admission of defendant that he cohabited for a certain time with the woman claimed by the state to be his wife, are admissible. A letter by...
