Yet the annual rental as such never accrued, and the breach declared on is not a failure to pay rental but a failure to drill; and the plaintiffs only remedy was an action for damages. 3. Charging the defendant with the payment of 800 rental as of March 1, 1887, is holding it responsible for a breach committed by its assignor. An assignee of a lease is liable only by reason of privity of estate, and, therefore, only for breaches of covenants committed while that privity exists: *Negley v. Morgan*, 46 Pa. 281. The plaintiffs only remedy being an action for damages for breach of the covenant to drill the second well, against the assignee in possession at the time of the breach,...
